How you can help your clients, and yourself.

There is recent land reform legislation, by the Scottish Parliament, that may affect your organisation, and also your clients. We're giving you this toolkit to help you understand and potentially act on it, and to also communicate it to your clients.

This bespoke pack about the legislation, and corresponding Register of Persons Holding a Controlled Interest in Land in Scotland (RCI, for short), contains everything you need to know about what action you and your clients may need to take to avoid the risk of a fine of up to £5,000. We're sure your clients will see this as another benefit of being with you.

The background to this pack.

The new legislation.

To help Scotland improve transparency about land ownership by making information about those who have a controlling interest in land publicly available; new legislation was introduced by the Scottish Government and passed by the Scottish Parliament. This means that you and your clients may have to submit details to a new register.

The RCI launched on 1 April 2022. Information submitted to the register about those who have a controlling interest in land will be publicly available – that is, those who ultimately make decisions about the management or use of land, even if they are not necessarily registered as the owner of the land.

Actions required.

To comply with the new legislation, individuals need to check if they are legally required to submit to the register, and if they are in scope, make a submission before the deadline of 1 April 2024. After this date, offence provisions apply for non-compliance and you, and your clients, could be at risk of a fine of up to £5,000. Even if you, or they, are not in scope right now, it's important to be aware of this legislation as your circumstances may change in the future.

This pack contains details of what needs done by you and your clients. We ask you to read and share this information urgently.






Key points for you and your clients to know.

- You may have to submit an entry to the new Register of Persons Holding a Controlled Interest in Land, in Scotland.
- There's a deadline for entries by the 1 April 2024.
- After this date, you might be at risk of a fine of up to £5,000.
- Even if you are not in scope right now, it's important to be aware of this legislation as your circumstances may change in the future and bring you in scope of the legislation.

We're sharing this information with you to help you avoid the risk of a fine of up to £5,000. Scotland wants improved transparency about land ownership. So, new legislation has been introduced by the Scottish Government and passed by the Scottish Parliament. As part of this, a new register has been established. You may have to make a submission to this register.

Who might need to register?

If you're a registered owner of land or property in Scotland, or a registered tenant with a lease of more than 20 years, and someone else has a controlling interest in that land or property – you're legally obliged to act before 1 April 2024. Or, you could risk a fine of up to £5,000.

Even if you are not in scope right now, it's important to be aware of this legislation as your circumstances may change in the future and bring you in scope of the legislation.

The new legislation.

The new register, called the Register of Persons Holding a Controlled Interest in Land in Scotland (RCI, for short), launched on 1 April 2022. It exists to improve transparency about land ownership by making information about those who have a controlling interest in land publicly available – that is, those who ultimately make decisions about the management or use of land, even if they are not necessarily registered as the owner of the land. If these conditions apply to you, failure to register could result in a fine.

Act now to avoid the risk of a fine of up to £5,000.

To comply with the new legislation, you, as an individual, need to check if you are legally required to submit to the register before the deadline of 1 April 2024, after which point you could risk being fined up to £5,000.








